

CITY OF HOLLAND RESIDENTS WITH DUMPSTER EXPENSES RESULTING FROM THE JUNE 19, 2009 STORM

Holland City Council has approved a program to consider applications for partial reimbursement of storm related dumpster expenses. The program is limited to storm related dumpster expenses incurred between June 20 and June 26, 2009 for residential properties. As a resident, you may request consideration for reimbursement of up to 50% of expenses. Submit the following documents to: Cindy Osman, 270 River Avenue, Holland, MI 49423 or by e-mail to c.osman@cityofholland.com, or by fax to 616-355-1346:

1. Completed application for consideration (available at www.cityofholland.com)
2. Invoice or statement from the company that provided the dumpster. It must contain the date of delivery, address of delivery, and an indication that the pick-up was storm related.
3. Evidence of payment such as a paid statement, cancelled check, or credit card statement.
4. Name and contact information for the homeowner's insurance carrier.
5. Signature affirming that payment for the refuse pick-up was not made or reimbursed by the homeowner's insurance carrier.

ALL DOCUMENTS MUST BE SUBMITTED OR POSTMARKED ON OR BEFORE NOVEMBER 6, 2009 FOR CONSIDERATION. YOU MAY RECEIVE UP TO 50 % REIMBURSEMENT FOR A DUMPSTER USED TO REMOVE RESIDENTIAL DEBRIS RESULTING FROM THE JUNE 19, 2009 STORM.
